In 2023, in support of a more robust organizational structure around issues such as **climate action**, **environmental justice and efficiency of the City's capital assets**, the Office of Climate and Sustainability was established, and I was named the City's first Climate and Sustainability Officer. The managing director role is responsible for oversight and direction of a diverse program portfolio including but not limited to climate action with projects ranging from **policy development and legislative advocacy to multi-million-dollar grant management and coordination across multiple federal agencies to capital project planning and investment**. The following duties are in addition to those of the Director of Community and Human Development and Chief Resilience Officer.

- Development and implementation of the first regional Climate Action Plan in coordination with 12 regional governmental bodies, multiple utility providers and more than a dozen community benefit organizations made possible by local bond funds in addition to federal grant dollars through the Infrastructure Reinvestment Act and American Rescue Plan Act.
- Act as regional lead for identification, development and implementation of Climate Action Mitigation and Adaptation strategies specific to the urban desert environment with emphasis on producing tangible results for all regional residents.
- Oversee development, coordination and administration of the City's Sustainability related initiatives and Climate Action
 programs/services across all city departments with the intention of promoting a healthy environment, an excellent quality of life,
 viable neighborhoods and continued economic vitality in a changing global environment.
- Lead governing bodies across west Texas, Southern New Mexico and Northern Mexico coordinating data collection, strategy and implementation of programs and projects resulting in improved health and economic outcomes for the entire Paso Del Norte region

Director of Community + Human Development, City of El Paso / Chief Resilience Officer, City of El Paso December 2014- Present

The Chief Resilience Officer was established an executive position resulting from a partnership with the Rockefeller Foundation, 100 Resilient Cities Program. As the first Latina in the world to hold this position in municipal government my core responsibility was to work across all city departments, community partners, business and El Paso residents to assess local vulnerabilities, analyze community assets and develop strategies aimed at enhancing El Paso's ability to survive, adapt and thrive in the face of a dynamic set of shocks and stresses unique to our binational metroplex. Following 2 years of engagement and documented communication with over 70,000 residents the result was the City of El Paso Resilience Strategy. Published globally, the strategy was identified as exemplar of how to integrate and embed resilience in City Strategic Planning development and implementation.

In 2017, in addition to continuing my role as Chief Resilience Officer I was given the additional responsibility of becoming the Director of Community and Human Development. In that role I was tasked with reinventing the City's efforts to address the needs of El Paso's most vulnerable populations while prioritizing engagement for underrepresented populations and enhancing support and leadership for of all 81 El Paso neighborhood associations. Strategic management and compliance for the City of El Paso's entire HUD entitlement portfolio, state housing funds and variety of other competitive federal and philanthropic grants are foundational responsibilities in this role. Key results and performance indicators were established in the areas of social impact, economic development, housing affordability, community engagement and access to public services for area residents. The following are key areas of responsibility and accomplishment:

Fiscal Responsibility + Budget Management

- Complete Resolution of federal department of enforcement report, Office of the Inspector General, regarding over 7 years of audit findings remaining from previous leadership, related to the federal entitlement (City was cleared of any punitive measures), maintaining a record of zero findings in the 8 years since.
- Complete restructure of City policies and procedures surrounding federal funding to maximize community impact and minimize fiscal risk to the City of El Paso.
- Elevated the City of El Paso from a high risk standing to an exemplar city of best practice regarding adherence to federal regulation and impactful management of federal funds
