**Project Summary:** The City of El Paso is requesting \$5,000,000 from the FY26 Community Project Funding program for the I-10 Deck Plaza Project (Project). The Project is supported by multiple local, state, and Mexican public agencies and stakeholders and private sector partners (see community support attachment).

**Scope of Work:** Funding will be utilized for on-system (TxDOT) structural improvements for the I-10 Deck Plaza including retaining walls, support beams, fire safety, and utilities over a 6-block (0.38 miles) length of Interstate Highway 10 (I-10) in Downtown El Paso, Texas.

FHWA On-System / Off-System Analysis: The I-10 Deck Plaza is an on-system project and is included in the RMS2050 Metropolitan Transportation Plan (2022) (MTP) (Page 8-6).

**Funding Experience:** The City of El Paso has a long history of undertaking feasibility studies and design, construction of transportation capital improvements projects, including improvements made to international ports of entry. The City of El Paso is currently administering \$120+ million in federal discretionary grant projects and has received more than \$1 billion in grant funding from 2017 – 2024. The City of El Paso has experience managing appropriation funds submitted under the FHWA account.

### **Project Readiness:**

In 2024, the City of El Paso completed 30% feasibility design documents with a grant from the USDOT FY21 RAISE program (Award No. 693JJ32340222). The estimated Project duration is 24 months with funding allocated within 12 months (or as required by FY26 CPF).

6 additional attachments are being submitted with this application.

**Budget and Funding Justification:** The City of El Paso will provide a 15% match and the Deck Plaza Foundation will provide a 5% match for the FHWA appropriation. There are no pre-award costs included in this project budget. The appropriation will be executed via an Advanced Funding Agreement with TxDOT as a passthrough. No delays are foreseen.

There are currently very limited federal funding opportunities intended construct infrastructure on highway decks. The City of El Paso has engaged USDOT, the U.S. Economic Development Administration (EDA), and the North American Development Bank (NADB) for funding to design and construct this project in El Paso. To date, the City of El Paso has only achieved limited success. Specifically, the City of El Paso, El Paso MPO, and Paso del Norte Community Foundation have submitted grant applications for the design and construction of the Deck Plaza and have received Highly Recommended scoring criteria by FHWA but were ultimately not selected for funding in FY23 and FY24.

# Why Should this Request be Considered a Priority for the People of El Paso or Texas' 16th Congressional District?

The Project will physically reconnect Downtown and Uptown El Paso, de-emphasize the current vehicular-centric environment, and facilitate all modes of travel, especially for pedestrians, cyclists, and public transit users. Transportation challenges impacting the I-10 Downtown corridor include traffic growth, deficient roadway infrastructure, safety concerns, and the lack of multimodal mobility options, which limit the ability of residents to access areas where they live, work, heal, learn, play, and pray.

The Deck Plaza is a community-led complement to the TxDOT Downtown10 Project, not a contributor to the highway expansion. The Deck Plaza will address incomplete segments of streets crossing I-10 where pedestrians encounter unsafe environments, often as a result from lacking pedestrian amenities. Wide, high-speed, one-way streets, and with buildings that do not front the street are common.

The Project can address transportation needs while honoring a historical pedestrian system of green spaces and plazas prior to the construction of I-10 and recreating a sense of community in downtown and uptown El Paso.

Community Participation and Engagement: The City of El Paso and Paso del Norte Community Foundation engaged in multiple dedicated community outreach efforts in support of the I-10 Deck Plaza project. The I-10 Deck Plaza Planning Study (included in Supporting Documents) includes a planning initiative where public comments can be viewed at a dedicated website.
